

LOUISIANA PARENTS' GUIDE TO GRADUATED DRIVER'S LICENSE LAWS

All driver's education students must be at least 14 years and 9 months of age and have obtained and have in their possession a temporary instructional permit (TIP) in order to participate in the administration of the knowledge test. Students must be 15 years of age or older in order to operate a motor vehicle during on-road driving skills instruction. A student must be 16 years of age or older and have held a learner's permit for 180 days to participate in the administration of an on-road driving skills test.

AGE 14

Student may participate in the classroom instruction only at age 14 and 9 months

AGE 15

Learner's Permit Licensing Requirements

Successful Completion of Driver's Education Course

Pass Visual Exam

Pass Written Test with OMV or Driving School

Restrictions-02

Must be accompanied by a licensed parent, guardian, adult at least age 21 or licensed sibling at least age 18

No cell phone usage, including hands-free

Must complete at least 50 hours of supervised driving, 15 of those hours at night

AGE 16

Intermediate Licensing Requirements

Possess Learner's License for a minimum of 180 days

No At-Fault Crashes with Learner's License

No Moving Violations with Learner's License

No curfew, drug or alcohol law violations

AGE 16 (CONT.)

Pass Road Skills Test with OMV or Driving School

Restrictions

Restricted driving between 11pm-5am with licensed parent/guardian, licensed adult at least 21 yoa or licensed sibling 18 yoa or older

May not transport more than one passenger under 21 yoa between 6pm-5am unless the passenger is immediate family

No cell phone usage, including hands-free

AGE 17

Complete requirements for Intermediate License

No At-Fault Crashes (12 consecutive months)

No Moving Violations (12 consecutive months)

No curfew, drug or alcohol law violations (12 consecutive months)

Upon completion of driver's education, the TIP will be surrendered to OMV along with proof of completion of the driver's education course and any other necessary documents

There is no additional cost to convert from the TIP to a Learner's Permit or License

ORGAN, EYE AND TISSUE DONATION & EDUCATION

DEAR PARENT/GUARDIAN,

During Drivers' Education, your child will be learning about organ, eye and tissue donation and transplantation. Every person applying for a TIP card, Learner's Permit, Driver's License or identification card at the Office of Motor Vehicles will be asked about their wishes to become a registered donor.

The information discussed will:

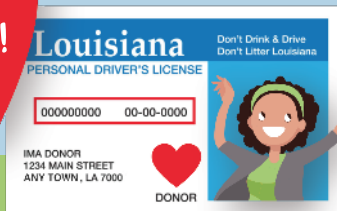
- ♥ Provide students with basic information for making an educated decision about becoming an organ, eye and tissue donor.
- ♥ Encourage students to discuss this important topic with their parent(s) or guardian(s) prior to visiting the OMV.
- ♥ Educate students about donation and the ability of transplants to save and enhance lives.

Please take some time as a family to discuss this decision.

Even though it may feel a little uncomfortable, having a brief discussion now could someday make a decision about donation easier. Many families have shared that they wished they had known how their loved one felt about organ, eye and tissue donation.

Louisiana's Organ Donor Registry allows citizens to make legally binding decisions to be donors. Family consent is required for all minors. This makes it especially important for you to have a discussion with your loved ones about wishes regarding donation.

Individuals wanting to register as a donor can do so at the Office of Motor Vehicles, at DonateLifeLA.org or through the HealthApp on your phone.
